FEE STRUCTURE FOR 2017

The following non-refundable, once off registration and administration fee is payable on registration.

R11 000.00 (eleven thousand rand) for Grade 1-4,

R8 000 (eight thousand rand) for Grade 5,

R6 000 (six thousand rand) for Grade 6&7

Facility Fee for 2017

An annual facility fee of R2 800 is payable on the 15th of December with your January 2017 tuition fee.

This facility fee excludes: your stationery, book fee, camps, school uniform and the purchasing of art on the art exhibition.

It includes 2 outings a year, away from school and 2 events that will be arranged at school.

Your annual facility fee will be utilised to cover expenses relating to the upkeep of the building and procuring of educational material previously covered by fundraising.

School fees for 2017

Grades 1 & 2: R 5 500 x 12 months

R16 500 per Term

R66 000 per annum

A 5% discount will be given when the school fees are paid in full by the 1st of February 2017.

Grades 3 - 7: R 5 800 x 12 months

R17 400 per Term

R69 600 per annum

A 5% discount will be given when the school fees are paid in full by the 1st of February 2017.

As Shelanti is a no-cash institution a cash deposit fee will be added to your cash payment.

I/We confirm that this agreement is binding despite changes to my/our marital status, or any terms of settlement, which may arise from a divorce agreement.

In terms of Section 39 of the South African Schools Act, the parties to this form are liable to pay the compulsory school fees.

If payment is not received before the 5th of each month, the school reserves the right to charge a late payment fee of R100.00 per week until such time that the fees for the relevant month/s are paid. This late payment fee will automatically be added to your account.

I/We understand that our child will be refused entry to SHELANTI PRIVATE SCHOOL if payment is more than 7 days late.

I/We further agree, that in the event of my/our failing to pay tuition fees when the same are due, I/We will be liable for all attorney and own-client charges incurred by SHELANTI PRIVATE SCHOOL, to recover such fees, which costs shall include collection, commission and agents tracing fees.

I/We undertake to give 3 (three) months notice in writing of any intention to remove my/our child from the school and furthermore to return any books and/or equipment belonging to the school which our child may have. Shorter notice would require the payment of the following 3 months tuition fees. However should applications be secured and learners not attend the school, the paid registration and administration fee will be forfeited.
